acknowledge that I have voluntarily applied to participate in the Sun City Endurance ride.

I am aware that participating in this event involves the risk of injury to my person and property, involves being in remote areas for extended periods of time, far from communications, transportation, medical facilities; that these areas have many natural and man-made hazards which ride management cannot anticipate, identify, modify or eliminate, that accidents can happen to anyone at any time. I voluntarily accept all risk of personal injury (including death), and property damage arising from my attendance and participation in this event.

As lawful consideration for being permitted to participate in this event, I hereby agree that I, my heirs, personal representatives and assigns, will not sue or make any claims against the Bureau of Land Management, USEF, FEI, Mark Dial, David and Tracy Kaden, Specialized Saddles, Flight Leader Farm, all ride staff and organizers, Volunteers, invitees and affiliated entities for any injury or damage arising from the negligence of other acts, however caused, of the Ride, their employees, volunteers, officers, directors, members, agents, neighbors, contractors, guest, invitees, etc.

In addition, I hereby release and discharge the Bureau of Land Management, USEF, David and Tracy Kaden, Mark Dial, Specialized Saddles, Flight Leader Farm, all ride staff and organizers, Volunteers, invitees and affiliated entities, from all actions, claims or demands, that I, my personal representatives or assigns, now have or may hereafter have, for injuries or property damage resulting from my participating in the Sun City Ride. I agree that this release includes injury or damage caused in whole or in part by negligence, active or passive, of the Sun City Ride and all members, employees, volunteers, landowners, agents, neighbors and contracting parties. I have carefully read this agreement. I understand that it is a complete release of liability and a promise not to sue or to make any claims. I am aware that it is a contract between myself and sun city endurance ride
